Hawaii Manufacturing Facts

Manufacturers in Hawaii account for 2.1 percent of the total output in the state, employing 2.2 percent of the workforce. Total output from manufacturing was \$1.78 billion in 2016. In addition, there were 14,000 manufacturing employees in Hawaii in 2016, with an average annual compensation of \$46,148 in 2016.

Figure 1: Hawaii Manufacturing Output, in Billions of Dollars, 2005–2016





Figure 2: Top 10 Hawaii Manufacturing Sectors, in Millions of Dollars, 2015




Hawaii Export Facts

Manufacturers help to drive Hawaii's economy, with \$1.06 billion in manufactured goods exports in 2016. That same year, \$0.88 billion in exports was with our free trade agreement (FTA) partners. This helps create jobs in the state, and 4.7 percent of its employment stemmed from exports in 2011. Small businesses comprised 87 percent of all exporters in Hawaii.
